



# Creative Commons Licensing

## Introduction

In the history of copyright, there have been two designations, public domain and copyright. Works in the public domain, such as U.S. government materials can be used freely by anyone. Copyrighted works can only be used with permission of the copyright owner(s).

*Note:* it is not necessary to designate a work as copyrighted. It is automatically so, unless otherwise stated.

Creative Commons (<http://www.creativecommons.org>) provides multiple intermediate licensing possibilities that enable people to share and build on the works of others. For more on this aspect, please see: <http://creativecommons.org/about/>.

## The Licenses

There are six licenses (<http://creativecommons.org/about/licenses>) ranging from Attribution that “lets others distribute, remix, tweak, and build upon your work, even commercially, as long as they credit you for the original creation” to Attribution Non-Commercial No Derivatives that “allows others to download your works and share them with others as long as they mention you and link back to you, but they can’t change them in any way or use them commercially.”

Attribution Share Alike is a popular license because it requires that anyone using your materials license their products under the identical terms. This licensing level encourages collaboration and leverages the wisdom of the crowds.

## Applying a Creative Commons license to your work

The Creative Commons site provides a free service for licensing your work. Their web form is here: <http://creativecommons.org/choose/>. After you fill out the form and click Get License, you will be presented with a text box with the HTML code to embed at the bottom of your HTML page.

The license in the web page will look something like:
