PROCEDURE FOR APPLICATION FOR ADMISSION

Using the computer matching process

The deadline for application is February 17, 2009.

Applicants for admission by computer matching should do the following:

1. The applicant is to assume responsibility for his/her application to the Dietetic Internship (DI)
2. Send letter of application stating your professional goals as related to dietetics, as well as any other pertinent information including any personal information you may wish to share. Please include your reasons for applying to the UNCG program.
3. Send a copy of your resume.
4. Send the completed application forms:
 - a. Supervised Practice Program Application (2005 revised format) with additional questions required by UNCG.
 - b. References from three professional persons who can give information as to ability, potential, professional qualifications, character, appearance, and personality of the applicant. The references must include a major professor in food and nutrition. **All qualities rated “Outstanding” on the Recommendation Form must have written explanation on the back of the page for additional information.**
 - c. GRE Scores (Official Graduate Institution Report of Scores, not Student copy) Note: You will need to retake this exam if your scores are over 5 years old. You should allow a minimum of one month for scores to arrive by the deadline.
5. Send official transcript(s) of credits earned from All universities and colleges attended. Include graduate transcripts as well as undergraduate transcripts (to date), if applicable.
6. Send verification or completion of Didactic Program in Dietetics or Declaration of Intent to Complete Degree from Didactic Program Director at your university. This standardized form is to be completed and signed (blue ink) by the College/University Didactic Program Director, and must be no more than 5 years old.
7. Send internship application processing service charge of \$55 by check payable to Department of Nutrition (must accompany application)
8. Application materials will not be returned.
9. Note: All students matched to the DI program will be required to complete a criminal background check prior to placement in any site/facility.
10. All applicants to Dietetic Internships (DI), except those eligible for the preselect process, must participate in computer matching. Applicants should request this material from any ADA-approved/accredited Didactic Program in Dietetics Program or from D&D Digital Systems. There is no charge for this material. However, there is a \$50.00 charge for computer matching that is due with the applicant's prioritized ranking.
