**UNCG** provides access to a pre-law advisory committee who can help you design a comprehensive plan of study that will enable you to maximize your chances of gaining admission to any law school in the country. There is no prelaw major at UNCG. Law school admission committees do not require or suggest certain majors; however, regardless of your choice of major, they recommend that you choose a plan of study that helps you develop your abilities in four primary areas:

1. Effective writing and speaking skills
2. Logical and analytical thinking skills
3. Understanding of American institutions and values
4. Mastery of basic computer skills.

We encourage you to choose a major that you will enjoy and one that helps you develop these skills. You will do better in classes that you enjoy and your overall grade point average will increase. A high GPA, along with strong scores on the Law School Admissions Test (LSAT), will help you be admitted to the law school of your choice.

## Suggestions for Planning

1. Start your homework by reading and studying the UNCG Undergraduate Bulletin. Learn about the curriculum and about the courses that might be of interest to you.
2. Once you are familiar with the curriculum options, seek out your regular academic advisor. When you have questions pertaining to prelaw, make an appointment to talk to a member of the Prelaw Advisory Committee. Try to meet with a member of the committee early in your college career.
3. Contact Student Academic Services in 159 Mossman for information about curriculum requirements as well as general useful advice, which will help you be a successful student.
4. Visit the College of Arts and Sciences Advising Center in 25 Foust.
5. Visit the Career Services Center in 1 EUC to speak with a career counselor if you need help deciding among career options.
6. Visit the University Writing and Speaking Centers in 3211 HHRA for assistance in improving your academic skills.
7. Familiarize yourself with all the resources in Jackson Library, particularly the reference room on the first floor. The reference librarians are trained to assist students and scholars in finding information, including materials pertaining to careers. Librarians also have prepared bibliographies about the law.
8. Contact the Legal Professions Association (LPA) on campus. This student-led organization provides important information, speakers, and opportunities for students interested in legal careers. Contact any pre-law advisor at UNCG for information on how to join the LPA.
