WHAT IS Deaf-Blindness?

- Deaf-Blindness is defined as a combined vision and hearing loss that impacts an individual's learning, communication and interaction with the world.
- The type and the severity of the disability differs from child to child.
- Individuals with deaf-blindness need modifications and supports that go beyond what is typically needed with a hearing loss alone or a vision loss alone.
- Many children with deaf-blindness may also have multiple disabilities in addition to vision and hearing loss.

wно is Eligible for Services?

- A child does not need to be totally deaf or blind to qualify for services from the NC Deaf-Blind Project.
- Infants, toddlers and preschoolers who have a diagnosed condition that puts them at risk for having the combination of both vision and hearing loss.
- Children and youth who have been diagnosed with the combination of both vision and hearing loss that

results in the need for specialized instruction and services.

 Degenerative conditions that may lead to deafblindness.
